1. Apologies for absence

Apologies were received from Dr Alastair Beresford and Prof Alan Mycroft.

2. Sabbatical leave and substitute teaching

3. Review of course feedback

It was noted that of the thirteen Easter Term courses, five exceeded the Committee's requirement that at least ten students must fill in the feedback form. Of those five courses, none is a cause for concern. According to the feedback received:

- Algorithms I (Fraser) was excellent
- Artificial Intelligence I (SBH) was good, perhaps a tad fast in the last few lectures
- Complexity Theory (AD) was good, but perhaps too much material too close to exams
- Databases (TGG) was OK, notes could be organised better
- Introduction to Security (MGK) was excellent, perhaps should be 12 rather than 8 lectures

4. Review of staff-student consultative committee minutes

Dr Holden is waiting to receive the minutes from the secretary for the last two meetings. At the most recent meeting, the student representatives raised no issues which were of concern to the Teaching Committee.

5. Revision of the Tripos

The committee discussed a paper (TC0708/18) tabled by NAD which proposed a version E examination structure for Part IB. It was agreed that the Algorithms II questions should appear in the Applications Paper, the Concurrent Systems and Applications and ECAD (Verilog) questions should appear in the Programming and Professionalism Paper. NAD shall present this latest version to the Directors of Studies in Computer Science Forum meeting on Monday for feedback.

6. Development of the new MPhil in Computer Science

It was noted that the papers are to be considered by the Education Committee next week, the General Board the following week and then finally the Board of Graduate Studies before approval is granted. It was agreed that IJW will email all teaching staff with the course guide and module template and ask for proposed module specifications. Members of a management committee (a sub-committee of the Degree Committee) were nominated by the Teaching Committee to oversee these modules – EJB, GW, SMH, IJW and LMG.
